## CARBONRIGHT GIVEAWAY OFFICIAL RULES

Please read these Official Rules (the "*Official Rules*") of the CarbonRight Giveaway (the "*Giveaway*"). You must agree and comply with these Official Rules to participate in the Giveaway.

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE OR IMPROVE YOUR CHANCE OF WINNING.

1. <u>Sponsor</u>. The sponsor of the Giveaway is Questar Gas Company dba Dominion Energy Utah (the "*Sponsor*") having its principal business address is 333 South State Street, Salt Lake City, UT 84111.

2. <u>Agreement to the Official Rules</u>. By participating in the Giveaway using any entry method you fully and unconditionally agree to accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Giveaway.

**3.** <u>Who Can Enter?</u> The Giveaway is open to you only if you satisfy the following requirements: you must be at least 18 years of age at both the time that you enter the Giveaway and at the time the prize is awarded; you must be a legal resident of Utah; and you must reside in Sponsor's service territory. 4. <u>When Can You Enter?</u> The Giveaway begins at 12:00 AM MST on 8-1-23, and ends at 12 PM MST on 09-30-23 (the *"Giveaway Period"*).

## 5. How to Enter?

(a) <u>CarbonRight Program Enrollment Method</u>. All qualified persons who enroll in the Sponsor's CarbonRight program during the Giveaway Period either via the Internet (see <u>https://www.dominionenergy.com/utah/save-energy/carbonright</u>) or by calling Dominion Energy at 800-323-5517 will be automatically entered into the Giveaway unless they opt out of such entry as described in paragraph 8 below.

(b) <u>Email Method</u>. As an alternative you may enter the Giveaway by sending your name, age, complete street/mailing address (including zip code), and phone number (including area code) by email to <u>carbonright@dominionenergy.com</u> with the subject line "CarbonRight Giveaway Entry."

(c) <u>Mail-in Method</u>. You may also enter the Giveaway by printing your name, age, complete street/mailing address (including zip code), and phone number (including area code) on a 3<sup>1</sup>/<sub>2</sub>" by 5" card and mailing the completed card, with sufficient first-class postage affixed, to Dominion Energy Utah, Attn: CarbonRight Giveaway, PO Box 45360, Salt Lake City, UT 84145-0360. Mail-in entries for the Giveaway must be legible and submitted in original hand-printed form.

## (d) Limitations and Disclaimers.

(i) AN EMAIL OR MAIL-IN ENTRY PURSUANT TO PARAGRAPH 5(B) OR 5(C) ABOVE WILL BE DEEMED VALID AND ELIGIBLE FOR CONSIDERATION ONLY IF THE SPONSOR <u>ACTUALLY</u> <u>RECEIVES</u> SUCH ENTRY PRIOR TO THE END OF THE GIVEAWAY PERIOD.

(ii) All postage or Internet access and usage charges are your sole responsibility.

(iii) The Sponsor is not responsible for any problems or technical malfunctions of any telephone network or lines, computer on-line systems, servers or providers, computer equipment, software, failure of any e-mail or entry to be received by the Sponsor on account of technical problems or traffic congestions on the Internet or at any website, or any combination thereof, including any injury or damage to your or any other person's computer-related to or resulting from participation or downloading any materials in the Giveaway. Any such entries shall be deemed invalid and ineligible for purposes of the Giveaway.

(iv) The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, delay in delivery, communications line failure, theft or destruction or unauthorized access to, or alteration of, any Giveaway entries submitted pursuant to paragraphs 5(a) or 5(b).

(v) Entries generated by robots or scripts or other automated devices will be deemed to be a direct violation of these Official Rules, and any such entries shall be deemed invalid and ineligible for purposes of the Giveaway.(vi) The Sponsor is not responsible for any lost, late, misdirected, postage due, damaged, mutilated, illegible, indecipherable, incomplete, inaccurate, or deceptive Giveaway entries, all of which entries shall be deemed invalid and ineligible for purposes of the Giveaway.

**6.** <u>How Many Times May You Enter?</u> Only ONE (1) entry per household is permitted during the Giveaway Period. In the event that more than one entry is received with respect to any participant the participant's first entry will be considered the only valid entry.

7. <u>What is the Prize?</u> The prizes include five (5) one hundred dollar (\$100) Visa gift cards (each a "*Prize*") to be awarded individually.

**8.** <u>May I Cancel My Entry</u>? If you wish to have your entry removed from the Giveaway, please send an email with the subject line "CarbonRight Giveaway Opt Out" with your name and complete street/mailing address (including zip code) to <u>carbonright@dominionenergy.com</u>.

**9.** <u>How is the Prize Recipient Determined?</u> During the Giveaway Period, eligible Giveaway entries received pursuant to paragraph 5(a) will be combined with the eligible email and/or mail-in Giveaway entries received by the Sponsor pursuant to paragraphs 5(b) and 5(c) to create the entry pool for the Giveaway (the "*Entry Pool*"). On 8-01-23, or on some other date (as determined by the Sponsor in its sole discretion) (the "*Prize Drawing Date*") following the conclusion of the Giveaway Period, five (5) potential recipient(s) of the Prize (each a "*Prize Recipient*") will be selected by means of a random drawing conducted by the Sponsor from among all eligible entries contained in the Entry Pool. All decisions of the Sponsor regarding the Prize drawing and any and all other aspects of the Giveaway shall be final, binding, and non-appealable. Your odds of receiving a Prize (or any other prize awarded hereunder) will be determined by the total number of eligible Giveaway entries. Such odds are equal regardless of the method of entry used to enter the Giveaway.

**10.** <u>How is the Prize Recipient Notified?</u> Shortly after the Prize drawing described in paragraph 9, the Sponsor shall endeavor to notify the Prize Recipient, including by certified mail. If the Prize Recipient fails to respond to the Sponsor within seven days after being notified by the Sponsor, or if such notification or the Prize itself is returned as undelivered, then the Prize Recipient is deemed to have forfeited any and all rights to receive the Prize, and the Sponsor may elect to (but shall not be required to) select an alternate Prize Recipient by means of another random drawing pursuant to the procedure described in paragraph 9 from among the remaining eligible Giveaway entries.

12. <u>Ownership of Giveaway Materials</u>. Your Giveaway entry, together with any and all accompanying or other Giveaway-related materials submitted by you, shall become the exclusive property of the Sponsor and will neither be acknowledged nor returned.

**13.** <u>Proof of Identity and Affidavit</u>. If you are a Prize Recipient, you may be required to: (a) furnish photographic identification in the form of a government issued document; and (b) furnish a signed affidavit or such other documentation (i) acknowledging your acceptance and compliance with these Official Rules, (ii) confirming your eligibility to participate in the Giveaway, and (iii) providing the Sponsor any other reasonably requested information, including, without limitation, your social security number and any other information required for tax reporting purposes, in a form determined by the Sponsor. Failure to furnish such information and signed affidavit within the time period stated in the Sponsor's request may cause disqualification.

pursuant to Section 11 of these Official Rules, without any obligation on the part of Sponsor (1) to pay any additional compensation (of any kind or amount) to such Prize Recipient, or (2) to seek or obtain the approval of such Prize Recipient.

**15.** <u>Governing Law.</u> This Giveaway shall be governed by the laws of the state of Utah. THE GIVEAWAY IS VOID WHEREVER PROHIBITED BY LAW.

**16. Limitation of Liability and Release.** The Sponsor, including its parent companies and affiliates, shall have no liability to you or any third party for consequential, incidental, or punitive damages caused by, related to, or arising from your participation in the Giveaway. You hereby release the Sponsor, its parent companies, and other affiliates, and their respective directors, officers, managers, members, partners, agents, employees and representatives from any and all claims, costs, injuries, losses, or damages of any kind caused by your participation in the Giveaway.

**17.** <u>**Taxes.**</u> All federal, state, and other tax liabilities arising from the Giveaway are the sole responsibility of the Prize Recipient. If applicable, a Form 1099 will be sent to the Prize Recipient.

**18.** <u>Disputes.</u> As a condition of partipating in the Giveaway you agree that any disputes between you and the Sponsor not resolved via negotiation shall be resolved exclusively before the courts of the state of Utah. Any proceedings to resolve or litigate any dispute will be conducted solely on an individual basis. Any dispute must be brought in your individual capacity, and not as a plaintiff or class member in any purported class, collective, representative, multiple plaintiff, or similar proceeding ("*Class Action*"). YOU EXPRESSLY WAIVE ANY ABILITY TO MAINTAIN ANY CLASS ACTION IN ANY FORUM.

**19.** <u>Use of Information; Privacy</u>. All information collected by Sponsor in connection with the Giveaway is subject to Sponsor's <u>Privacy Notice</u>, which is available at <u>https://www.dominionenergy.com/privacy</u>.
