

VOLUNTARY CONSENT FORM

A Transmission Customer may provide written consent to allow Dominion Virginia Power (Dominion Energy Virginia) transmission function employees to share the Customer's non-public information with Dominion Virginia Power's marketing function employees. Dominion Virginia Power will post notice on its electronic bulletin board of the Customer's consent along with a statement that Dominion Virginia Power did not provide any preferences in exchange for the voluntary consent.

Pursuant to the Federal Energy Regulatory Commission's regulations, 18 C.F.R. §358.7(c), and, if applicable, the regulations of the Virginia State Corporation Commission and/or North Carolina Utility Commission, MP2 Energy NE LLC (Customer) hereby provides voluntary consent to the disclosure of Customer's non-public information by Dominion Virginia Power's transmission function employees to the marketing function employees of Dominion Virginia Power. The purpose of Customer's consent is to permit the transmission function and marketing function to coordinate efforts with regard to Customer's load and Dominion Virginia Power's fulfillment of Fixed Resource Requirement obligations and related planning.

Customer acknowledges that notice of this consent will be posted on Dominion's Internet bulletin board and this consent has not been given in exchange for any rate or operational preferences. Customer's consent is subject to the following limitations: Dominion Energy Virginia and any Marketing function employees who receive such information agree to use the information solely for the purpose of Dominion's fulfillment of Fixed Resource Requirement obligations and related planning. Further, Dominion Energy Virginia and any Marketing function employees are not authorized to disclose such information to anyone else, including other units within Dominion Energy Virginia. Finally, Customer may withdraw its consent upon written notice to Dominion Energy Virginia. This consent shall be interpreted, construed and governed by the laws of Virginia exclusive of the conflicts of laws provisions. This consent shall be binding on and inure to the benefit of Dominion Virginia Power's and Customer's respective heirs, successors, assigns, and affiliates. Nothing stated herein shall be construed to require Dominion Virginia Power to take any action in violation of applicable laws or regulations.

Customer represents and warrants to Dominion Virginia Power that:

- (a) It is duly organized, validly existing and in good standing under the laws of the jurisdiction of its formation;
- (b) It has all authorizations necessary for it to legally grant this consent;
- (c) The execution, delivery and performance of this consent are within its powers, have been duly authorized by all necessary action and do not violate any of the terms and conditions in its governing documents, including, but not limited to, any organizational documents, charters, by-laws, indentures, mortgages or any other contracts or documents to which it is a party, or any law, rule, regulation, order or the like applicable to it; and
- (d) This consent constitutes its legally valid and binding obligation enforceable in accordance with its terms.
