**Waller – Lightfoot – Skiffes Creek 230 kV Electric Transmission Line Rebuild Project**

Dear Neighbor:

At Dominion Energy, we are dedicated to finding the best solution for our long-term energy needs in the communities we serve. You are receiving this letter as a reminder that construction is scheduled to begin this summer on the Waller – Lightfoot – Skiffes Creek 230 kV Electric Transmission Line Rebuild Project in Williamsburg, York County, and James City County, Virginia. This work is necessary to maintain service reliability for our customers.

As part of this project, we will rebuild approximately 13-miles of the existing transmission line between our Skiffes Creek, Waller, and Lightfoot substations in the same right of way with new structures that look similar to the existing structures installed in the late 1960s. The new single-circuit and double-circuit weathering steel H-frame structures will be taller, on average, than the existing wooden H-frame structures.

Throughout the next few months, you may notice our crews or contractors accessing properties along the right of way corridor to survey and perform preconstruction activities, including tree/brush clearing in and around the right of way and building access roads with wooden matting to protect existing vegetation.

There are two construction sections for this project. Construction between our Skiffes Creek and Waller substations will begin in summer 2022 and end in spring 2023. Construction between our Waller and Lightfoot substations will begin in winter 2022/2023 and end in summer 2023. Restoration activities continue through 2023 and 2024.

Your electric service is not expected to be interrupted as a result of this project. We are committed to working safely and courteously in your neighborhood and will restore the right of way once work is complete. As the project progresses, additional updates will be provided.

Please maintain a safe distance from construction sites for your protection and to allow our crews to work safely.
