

RIDER VCR 20232023 VOLUNTARY CUSTOMER REFUND RIDER

The following Virginia Electric and Power Company filed Rate Schedules and special contracts approved by the State Corporation Commission pursuant to Virginia Code § 56-235.2 shall be increased by the applicable cents per kilowatt-hour charge. Rider VCR 2023 will be used for calculating customer credits based on the generation component of the Customer's Electricity Supply kilowatt-hours purchased from the Company for usage on and after January 1, 2017 through and including December 31, 2020. Once such calculations have been completed, Rider VCR 2023 will no longer be effective and will be withdrawn.

In accordance with the Commission's Final Order in Case No. PUR-2021-00058, the Company will provide an aggregate amount of Rider VCR 2023 bill credits totaling \$25 million to eligible customers. The billing of customer credits will begin in January 2023 and will be amortized over a period of twelve (12) months.
