

**Dominion Energy “2019 Stress less with eBill” Sweepstakes
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF PROMOTION: The Dominion Energy “2019 Stress less with eBill” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Time (“ET”) on July 1, 2019 and ends at 11:59 p.m. ET on September 13, 2019 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to persons who are legal U.S. residents, with a residency in the states of Virginia or North Carolina and are eighteen (18) years of age or older at time of entry (the “Entrant”). Business entities are not eligible to participate in this Sweepstakes. Officers, directors, managers and employees, including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside and members of the same household, whether or not related) of Dominion Energy (the “Sponsor”) its respective parent, subsidiaries, affiliates and related companies; licensees, distributors, retailers, dealers, printers, advertising and promotion agencies; consultants and agents; and any others engaged in the development, production, execution or distribution of this Sweepstakes, including National Sweepstakes Company, LLC (the “Independent Administrator”) (herein, all collectively referred to as “Sweepstakes Entities”) are not eligible to participate or win a prize. This Sweepstakes is subject to all federal, state and local laws and regulations. This Sweepstakes is void outside the states of Virginia, North Carolina and wherever else restricted or prohibited by law.

HOW TO ENTER: There are two (2) ways to enter the Sweepstakes; however, regardless of the method used to enter the Sweepstakes, either via Online Entry (defined below) or AMOE (defined below) the maximum number of entries allowed during the Sweepstakes Period is one (1) per person.

1. **Existing eBill Customers:** Existing Dominion Energy customers who enrolled in paperless billing (“eBill”) prior to July 1, 2019 will automatically receive one (1) entry into the Sweepstakes.

2. **New eBill Customers (Online Entry):** Entrants entering the Sweepstakes via Online Entry must be a new or existing Dominion Energy customer during the Sweepstakes Period. To receive an entry into the Sweepstakes via Online Entry, Entrants must enroll and be accepted to receive his/her Dominion Energy bill during the Sweepstakes Period via his/her personal financial institution’s eBill services* (using the respective financial institution’s website as described below) OR via Dominion Energy’s eBill services (using the Website as described below). New and existing Dominion Energy customers may enter online as follows:
 - a) **Via the Dominion Energy Website:** To enroll via Dominion Energy, visit www.dominionenergy.com/ebill (the “Website”) during the Sweepstakes Period. If you are an existing online customer, select sign in and enroll in eBill. Otherwise, select register. Then, create your user profile by submitting all of the information requested. *NOTE: You will need a valid email address, your PIN and your Dominion Energy Account number to create your user profile.* Then, select the box for “eBill” to activate the eBill Activation Request (defined below). Once you have submitted your information, you will see a confirmation screen and receive one (1) entry into the Sweepstakes.

 - b) **Via Personal Financial Institution:** To enroll via your financial institution, visit your financial institution’s home banking website during the Sweepstakes Period and locate their “Online Bill Pay” section. Then, follow the online instructions to request Dominion Energy eBill paperless billing activation by submitting the information for your Dominion Energy account required by your financial institution (the “eBill Activation Request”).

**Not all financial institutions offer eBill. In the event your financial institution does not provide eBill services, you may enter the Sweepstakes via the Website (above) or the Alternate Method of Entry described in section “3” below.*

NOTE: In order to obtain an entry into the Sweepstakes via Online Entry through your personal financial institution, Dominion Energy must have accepted your eBill Activation Request. Dominion Energy makes every effort to accept or reject eBill Activation Requests no later than two (2) business days from the date in which the eBill Activation Request was submitted through your financial institution’s banking website. You will receive notification of Dominion Energy’s acceptance or rejection of your eBill Activation Request at your financial institution’s banking website.

For Example: An Entrant who submits an eBill Activation Request on August 1, 2019 will receive notification of acceptance or rejection from his/her financial institution no later than 11:59 p.m. ET on August 6, 2019 in order to receive an entry into the Sweepstakes via Online Entry.

In the event an Entrant does not receive notification of acceptance from his/her financial institution within two (2) business days of submitting the eBill Activation Request, such Entrant will not be afforded an entry into the Sweepstakes via Online Entry and may obtain entry into the Sweepstakes via the Alternate Method of Entry listed in Section “3” below. **All initial eBill Activation Requests must occur before the end of the Sweepstakes Period, no later than 11:59 p.m. ET on September 10, 2019.** Entrants will receive notification of acceptance / rejection from his/her financial institution in the form of a message on the financial institution’s Bill Pay website and may check the status of their eBill Activation with their financial institution at any time after the eBill Activation Request has been submitted. Once an Entrant has received confirmation that the eBill Activation has been accepted, he/she will automatically receive one (1) entry into the Sweepstakes.

- 3. Alternate Method of Entry (“AMOE”):** To enter the Sweepstakes without being a Dominion Energy customer and/or without performing an online transaction, you may enter by mail as follows: On a plain 3” x 5” card, legibly handprint or type your first name, last name, complete address, city, state, zip code, home phone number (including area code) date of birth, and email address (if any) and mail your completed 3” x 5” card to: “2019 Stress less with eBill” Sweepstakes, PO Box 10278, Rochester, NY 14610. Each envelope shall equal one (1) entry. Limit of one (1) entry by mail per person during the Sweepstakes Period. Entries must be postmarked by September 13, 2019 and received by September 21, 2019. Multiple entries submitted by a single Entrant or in the same envelope are void. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage due AMOE Entries.

Regardless of the method used to enter the Sweepstakes, either via Online Entry or AMOE the maximum number of entries allowed during the Sweepstakes Period is one (1) per Entrant. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, telephone numbers, identities, and/or any other methods (including, but not limited to enrolling and un-enrolling in eBill services for the purposes of obtaining additional entries), will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. In the event of uncertainty as to the identity of an Entrant entering via the Online Entry method, the Entrant will be deemed to be the first named person of the Dominion Energy account associated with the eBill Activation. **Limit of one (1) prize per person during the Sweepstakes Period.**

WINNING/ODDS: On or about September 23, 2019, four (4) prize winners will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The first winner selected will be the grand prize winner (“Grand Prize Winner”), and the next three (3) prize winners selected will be first prize winners (each a “First Prize Winner”). Odds of being selected as a prize winner are dependent upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted under the supervision of the Sponsor whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects. Any potential prize winner who entered the Sweepstakes via eBill Activation, must still be enrolled in eBill upon the drawing date and awarding of the prize, subject to verification and each such potential prize winner must also be in “good standing” (defined as Dominion Energy account holders who are making regular payments and/or accounts not in jeopardy of any pending credit action).

PRIZES:

Grand Prize: One (1) Grand Prize of a trip for two (2) for one of the following vacations: 1. Spa Relaxation, 2. Camping Trip, or 3. Fishing Excursion (the “Grand Prize Package”). Grand Prize winner has the option to choose one (1) of the Grand Prize Packages. Below are the elements of each Grand Prize Package Option:

1. Spa Relaxation is inclusive of: i) three (3) days and two (2) nights standard double occupancy hotel accommodations at a hotel determined by the Sponsor (Approximate Retail Value (“ARV”): \$1,400), ii) three (3) days of ground transportation of \$450 awarded as a check to the Grand Prize Winner to be used towards a rental car and gas (ARV: \$450), and iii) \$500 gift card to be used towards spa services (ARV: \$500). Total ARV of the Spa Relaxation Grand Prize Package is \$2,350.
2. Camping Trip is inclusive of: i) seven (7) days of camping at a campground of Grand Prize Winner’s choice (ARV: \$350), ii) one (1) Coleman Instant Tent with canopy (ARV: \$320), iii) two (2) zero gravity camping chairs, iv) two (2) camping lanterns (ARV: \$90), v) a Coleman camping grill (ARV: \$240), vi) a Yeti Hopper

Flip Cooler Bag (ARV: \$250), vii) a Yeti Tundra Haul Cooler (ARV: \$400), viii) a camping foldable table (ARV: \$80), ix) a Coleman cot with Air Mattress (queen) (ARV: \$140), x) two (2) Coleman Cots with air mattress (single) (ARV: \$200), xi) \$200 gift card to be used towards food or supplies. Total ARV of the Camping Trip Grand Prize Package is \$2,350.

3. Fishing Excursion is inclusive of: i) a fishing charter for a 4 hour ocean trip for up to four people (ARV: \$650), ii) three (3) days and two (2) night standard double or quad occupancy hotel accommodations at a hotel to be determined by the Sponsor (ARV: \$1,000), iii) three (3) days of ground transportation of \$450 to be awarded as a check to the Grand Prize Winner to be used towards a rental car and gas (ARV: \$450), and iv) a \$250 gift card. Total ARV of the Fishing Excursion Grand Prize Package is \$2,350.

Any difference in the stated ARV and the actual value at time of booking will not be awarded. Any expenses related to the Grand Prize Package including without limitation, any taxes, fees, gratuities and personal expenses, are the sole responsibility of the Grand Prize Winner. The Grand Prize consists of only the items specifically listed in the Grand Prize Package. Depictions of any part of the Grand Prize Package in any advertising or promotional materials may not reflect the actual Prize awarded to the Grand Prize Winner. Sponsor will determine itinerary in its sole discretion. No refund or compensation will be made in the event of a cancellation.

Grand Prize Winner and any Travel Companions must travel on the same dates and must confirm travel dates with Independent Administrator a minimum of thirty (30) days prior to travel or Grand Prize will be forfeited. In such case, no alternate prize will be awarded to such Grand Prize Winner and an alternate Grand Prize Winner may be selected. All travel must commence within one (1) year of the date for which the Grand Prize Winner has submitted the completed "Required Documents" as outlined in the "PRIZE CLAIMS" section below. All travel is subject to availability at time of request, blackout dates (including holidays) and other restrictions may apply. Itineraries are final once confirmed and may not be changed for any reason, other than at the sole discretion of the Sponsor. Grand Prize Winner and any Travel Companions must travel on same itinerary. The value of the Grand Prize Package may be taxable as income and Grand Prize Winner is solely responsible for any taxes, including but not limited to all applicable federal, state, and local taxes that become due with respect to the value of the Grand Prize Package. All other expenses not specifically mentioned herein as part of the Grand Prize Package, are the sole responsibility of the Grand Prize Winner.

Grand Prize Winner will be responsible for all meals, transportation, excursions, tips or gratuities, fuel, parking, beverages, telephone calls, overages, extras and any other incidental costs or expenses not specifically stated herein as being included or outside the value provided. Grand Prize Winner and ~~any~~ Travel Companion will be required to obtain and maintain all insurance (including health, liability and any other insurance). No changes will be made to travel details once any element(s) of the travel arrangements have been booked. Grand Prize conditions may be added or modified by Sponsor or its designee. Sponsor and Independent Administrator are not responsible for any changes of any element of the Grand Prize, nor are they liable for any expenses incurred as a consequence of event changes, cancellation or delays. Travel is subject to capacity controls, availability, and certain other restrictions, which may include a Saturday night stay, all of which are subject to change. Any unclaimed and/or unused element of the Grand Prize Package, or any element thereof, will remain the property of Sponsor or its designee. The Grand Prize Package restrictions/conditions stated herein are not all-inclusive and the described above may be subject to additional restrictions/conditions, which may be stated in the Affidavit (as defined herein), and/or other travel or release documents. In the event Grand Prize Winner and/or Travel Companion engages in behavior that, as determined by Sponsor (or its designee) in their absolute discretion, is obnoxious or threatening, dangerous, illegal or that is intended to annoy, abuse, threaten or harass any other person, or may cause harm, property damage or any other loss, Sponsor reserves the right to terminate the trip early, in whole or in part, and to send the Grand Prize Winner (and Travel Companion) home with no further compensation.

First Prizes: Three (3) first prizes of i) a Spa Kit, ii) Camping Kit, and iii) a Fishing Kit (each a "First Prize") will be awarded. Total ARV of each First Prize is \$500. The order in which the first prize winners (each a "First Prize Winner") were selected will determine which First Prize will be awarded to the First Prize Winner.

1. First Prize #1: Spa Kit is inclusive of: i) a gift certificate to a local spa, ii) bath bombs, iii) candles, iv) lotion, v) a robe, and vi) a neck pillow.
2. First Prize #2: Camping Kit is inclusive of: i) a Coleman Instant Tent, ii) a Coleman Lantern, and iii) a Coleman Cooler.
3. First Prize #3: Fishing Kit is inclusive of: i) a fishing pole, ii) chest waders, iii) a fishing lure set, and iv) a cooler.

The total ARV of all prizes to be awarded in the Sweepstakes is \$3,850. Prizes cannot be substituted, assigned, transferred, or redeemed for cash; except at Sponsor's sole discretion or as otherwise provided herein. Any gift card awarded is subject to any terms and conditions set forth on the gift card and issuer's standard terms and conditions applicable thereto. Sponsor reserves the right to substitute any prize with a prize of comparable or greater value if advertised prize should become unavailable. Sponsor will not replace any lost or stolen prizes. Prize winners are

solely responsible for any taxes on the prize he/she has received, including but not limited to any and all federal, state and local taxes. No more than the stated number of prizes set forth in these Official Rules will be awarded. **Limit of one (1) prize per person throughout the entire Sweepstakes Period.**

Names of prize manufacturers are used solely for the purpose of identification of the prize. No endorsement, authorization, sponsorship, or approval by any manufacturer stated in these Official Rules is intended or implied.

NOTIFICATION/PRIZE CLAIMS: Potential Grand Prize Winner will be notified within two (2) business days of the drawing. Except where prohibited, the potential Grand Prize Winner must sign and return within five (5) business days of receipt, an affidavit of eligibility/liability/publicity release (the "Release"), and an IRS Form W-9 in order to claim the Grand Prize (collectively, the "Required Documents"). If the potential Grand Prize Winner fails to return the Required Documents within five (5) business days of receiving it, potential Grand Prize Winner forfeits his/her right to the Grand Prize and another Grand Prize Winner will be selected at random from among the remaining non-winning eligible entries received during the entire Sweepstakes Period. **Potential Grand Prize Winner must report income to the IRS. In the event it is deemed during the verification process that potential Grand Prize Winner does not have a unique, personal and valid social security number for Sponsor to report the tax liability associated with acceptance of the Grand Prize, potential Grand Prize Winner will be disqualified and another Grand Prize Winner will be selected as outlined above. Valid social security numbers will be determined by IRS requirements.** The value associated with the Grand Prize is taxable as income and the Grand Prize Winner is solely responsible for any taxes, including, but not limited to all applicable federal, state, and local taxes that become due with respect to the value of the Grand Prize. The Sponsor must report the value of the Grand Prize to the Internal Revenue Service in the year the Grand Prize is received by the Grand Prize Winner and will be reported to the Grand Prize Winner and the Internal Revenue Service in the form of a 1099 form. First Prize Winners will be notified upon receipt of their prize approximately four (4) to six (6) weeks after the random drawing. First Prize Winners are not required to complete and return Required Documents.

All prize winners consent to Sponsor's use of their names, likenesses, biographical information, and voices in advertising worldwide without additional compensation (TN residents will not be required to sign a publicity release as a condition of winning a prize).

All First Prizes will be shipped directly to the First Prize Winners via FedEx, UPS or USPS within six (6) weeks from the date in which the First Prize Winners are selected and confirmed. In the event a First Prize is returned as undeliverable, the First Prize will be considered forfeited and an alternate First Prize Winner will be selected at random from amongst all remaining non-winning eligible entries received during the Sweepstakes Period.

GENERAL CONDITIONS: By entering, Entrant agrees to be bound by these Official Rules and all decisions of the Sponsor and Independent Administrator. Should any portion of the Sweepstakes be, in Sponsor's sole discretion, compromised by non-authorized human intervention or other causes which, in the sole discretion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes in a manner which in its sole discretion is fair, appropriate and consistent with these Official Rules. Notice of such action by Sponsor will be posted at the Sponsor's Website. In such event, Sponsor reserves the right to award the prize at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.**

RELEASE: By participating in this Sweepstakes, Entrants agree to release and hold harmless Sponsor and the Independent Administrator and each of their parent companies, respective officers, directors, managers, employees, subsidiaries, affiliated entities, agents, members, shareholders, insurers, servants, guests, divisions, predecessors, successors, representatives, assigns, attorneys, dealers, distributors, advertising, promotion, and fulfillment agencies (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt, redemption or use of any prize.

LIMITATIONS OF LIABILITY: The Released Parties do not have any responsibility or liability whatsoever for: (i); unauthorized human intervention in any part of the entry process or the Sweepstakes; (ii) electronic or human error

which may occur in the administration of the Sweepstakes or the processing of entries; (iii) any property loss, damage, personal injury, or death, in connection with the prizes provided pursuant to this Sweepstakes and/or any person's participating in the Sweepstakes; (iv) any printing or typographical errors in any Sweepstakes-related materials; (v) stolen, lost, late, misdirected, corrupted, incomplete, indecipherable or postage-due entries; or (vi) technical failures of any kind, including but not limited to the malfunctioning of any computer, mobile device, cable, network, hardware or software as applicable.
