

**Dominion Energy “2026 Online Account Registration” Sweepstakes
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF PROMOTION: The Dominion Energy “2026 Online Account Registration” Sweepstakes (the “Sweepstakes”) begins at 12:00 a.m. Eastern Time (“ET”) on January 1, 2026 and ends at 11:59 p.m. ET on February 15, 2026 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to persons who are legal U.S. residents, with a residency in the states of Virginia or North Carolina and are eighteen (18) years of age or older at time of entry (the “Entrant”). Business entities are not eligible to participate in this Sweepstakes. Officers, directors, managers and employees, including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside and members of the same household, whether or not related) of Dominion Energy (the “Sponsor”) its respective parent, subsidiaries, affiliates and related companies; licensees, distributors, retailers, dealers, printers, advertising and promotion agencies; consultants and agents; and any others engaged in the development, production, execution or distribution of this Sweepstakes (herein, all collectively referred to as “Sweepstakes Entities”) are not eligible to participate or win a prize. This Sweepstakes is subject to all federal, state and local laws and regulations. This Sweepstakes is void outside the states of Virginia, North Carolina and wherever else restricted or prohibited by law.

HOW TO ENTER: There are three (3) ways to enter the Sweepstakes; however, regardless of the method used to enter the Sweepstakes, either via Online Entry (defined below) or AMOE (defined below) the maximum number of entries allowed during the Sweepstakes Period is one (1) per person.

1. **Existing Online Account Customers:** Existing Dominion Energy customers who registered an online account prior to January 1, 2026, will automatically receive one (1) entry into the Sweepstakes.
2. **New Online Account Customers (Online Entry):** Entrants entering the Sweepstakes via Online Entry must be a new or existing Dominion Energy customer during the Sweepstakes Period. To receive an entry into the Sweepstakes via Online Entry, Entrants must register for an online account during the Sweepstakes Period via DominionEnergy.com. New and existing Dominion Energy customers may enter online as follows:
 - a) **Via the Dominion Energy Website:** To register an online account, visit www.dominionenergy.com/signin (the “Website”) during the Sweepstakes Period and select Register an Account. Then, create your account by submitting all the information requested. *NOTE: You will need a valid email address, your Dominion Energy Account number, last four digits of your Social Security Number, and zip code to create your account.*
3. **Alternate Method of Entry (“AMOE”):** To enter the Sweepstakes without being a Dominion Energy customer and/or without register an account online, you may enter by mail as follows: On a plain 3” x 5” card, legibly handprint or type your first name, last name, complete address, city, state, zip code, home phone number (including area code) date of birth, and email address (if any) and mail your completed 3” x 5” card to: “2026 Online Account Registration” Sweepstakes, Customer Experience, 2901 Charles City Road, Richmond, VA 23231. Each envelope shall equal one (1) entry. Limit of one (1) entry by mail per person during the Sweepstakes Period. Entries must be postmarked by February 15, 2026, and received by February 23, 2026. Multiple entries submitted by a single Entrant or in the same envelope are void. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage due AMOE Entries.

Regardless of the method used to enter the Sweepstakes, either via Online Entry or AMOE the maximum number of entries allowed during the Sweepstakes Period is one (1) per Entrant. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, telephone numbers, identities, and/or any other methods will void that Entrant’s entries, and that Entrant may be disqualified from the Sweepstakes. In the event of uncertainty as to the identity of an Entrant entering via the Online Entry method, the Entrant will be deemed to be the first named person of the Dominion Energy account. **Limit of one (1) prize per person during the Sweepstakes Period.**

WINNING/NOTIFICATION: There will be one (1) random drawing held on March 2, 2026, which twenty-five (25) Prize Winners will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of being selected as a Prize Winner in the drawing are dependent upon the total number of eligible entries received.

The random drawing decisions are based upon Sponsor's discretion and interpretation of these Official Rules and are final and binding in all respects. Any Prize Winner who entered the Sweepstakes via Online Entry, must still have an active online account upon selection, subject to verification. Any Prize Winner who entered the Sweepstakes via Online Entry must have an account in good standing upon selection, subject to verification. Potential Prize Winners will be notified by e-mail upon receipt of his/her Prize. In the event a Prize is returned as undeliverable, the Prize will be considered forfeited, and an alternate Prize Winner will be selected at random from amongst all remaining non-winning eligible entries received in the Sweepstakes Period.

PRIZES: One (1) Prize of a \$100 gift card will be awarded to each Prize Winner. The Approximate Retail Value ("ARV") of each Prize is \$100.00. The total ARV of all Prizes to be awarded in the Sweepstakes is \$2,500.00. Prizes cannot be substituted, assigned, transferred, or redeemed for cash; except at Sponsor's sole discretion or as otherwise provided herein. Sponsor reserves the right to substitute the Prize with a prize of comparable or greater value if advertised Prize should become unavailable. Sponsor will not replace any lost or stolen Prizes. Prize Winners are solely responsible for any taxes on the Prize he/she has received, including but not limited to any and all federal, state and local taxes. No more than the stated number of Prizes set forth in these Official Rules will be awarded.

Limit of one (1) Prize per person throughout the entire Sweepstakes Period. All Prizes will be awarded within six (6) to eight (8) weeks from the date in which all Prize Winners are confirmed. *Name of Prize manufacturers/trademark owners are used solely for the purposes of identification of the Prizes. No endorsement, authorization, sponsorship, or approval of Prize manufacturers/trademark owners is intended or implied by such use.* Potential Prize Winners consent to Sponsor's use of their names, likenesses, biographical information, and voices in advertising worldwide without additional notice or compensation.

GENERAL CONDITIONS: Should any portion of the Sweepstakes be, in Sponsor's sole discretion, compromised by non-authorized human intervention or other causes which, in the sole discretion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes in a manner which in its sole discretion is fair, appropriate and consistent with these Official Rules. Notice of such action by Sponsor will be posted at the Website. In such event, Sponsor reserves the right to award the Prizes at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
